The Information We Gather

The EARLY BIRD SPRING SOCCER INVITATIONAL TOURNAMENT LLC does not collect any personal information from a visitor to our web site unless that visitor explicitly and intentionally provides it. If you are simply browsing our web site, we do not gather any personal information about you. There are ways in which you may explicitly and intentionally provide us with and consent to our collection of certain personal information:

1. E-mail request for information – We use links throughout our web site to provide you with the opportunity to contact us via e-mail to ask questions, request information and materials, or provide comments or suggests.
2. Application to participate in the tournament - If you choose to apply to the STARBURST SOCCER SPECTACULAR TOURNAMENT, we will request certain information from you. We will require that you provide your or another person’s name, address, telephone number, e-mail address. In order for your application to be successfully submitted, you will need to provide a valid credit card number.

How We Use the Information We Gather

1. The EARLY BIRD SPRING SOCCER INVITATIONAL TOURNAMENT LLC will respond to any e-mail with questions, requests for information regarding the tournament and other inquiries that we receive. We may also retain this correspondence to improve our tournament, services, and web site,

and for other disclosed purposes. Frequently, we retain contact information so that we can send interested parties updates or other important information about our tournament.

2. We will use the information that you provide during the application process to organize and operate the STARBURST SOCCER SPECTACULAR TOURNAMENT. This specifically includes the placement of teams in the appropriate age, gender, and competitive level for each team.

3. We may also use the information you submit to contact you to discuss your satisfaction with the EARLY BIRD SPRING SOCCER INVITATIONAL TOURNAMENT and to make you aware of future EARLY BIRD SPRING SOCCER INVITATIONAL TOURNAMENTS and other tournaments that the EARLY BIRD SPRING SOCCER INVITATIONAL TOURNAMENT LLC may have a joint marketing arrangement.

If we are required by law to disclose certain information to local, state, federal, national or international government or law enforcement authorities, we will do so. We will also disclose information to third parties as necessary in order to comply with applicable laws and regulations. In addition, EARLY BIRD SPRING SOCCER INVITATIONAL TOURNAMENT LLC may share information in order to investigate, prevent, or take action regarding illegal activities or suspected fraud, or enforce or apply EARLY BIRD SPRING SOCCER INVITATIONAL TOURNAMENT agreements.

The Information on the Computer System

The information that is obtained at THEEARLYBIRDSOCCER.COM is maintained on a secure server, which hosted by the ACTIVE NETWORK of San Diego, California.

Information Security

All information that is provided through THEEARLYBIRDSOCCER.COM is secured both during transmission and online storage. If that information includes integrated payment processing, (i.e. credit card payments), the account information is not stored in the database associated with THEEARLYBIRDSOCCER.COM. Rather, the account information is forwarded to and stored by the credit card processor.
